## SECTION E. UNDER 18 CONFIRMATION OF APPROPRIATE ACCOMMODATION AND WELFARE (CAAW) ARRANGEMENTS

#### It is compulsory for students under 18 to book an airport pick up through UNSW College. If you have booked a homestay, you should request your homestay provider to arrange your airport pickup.

UNSW College will contact you if no arrangements have been made prior to arrival.

If you are under 18 and intending to study in Australia, you need to have appropriate accommodation and welfare arrangements in place before the Australian Government and Australian Department of Human Affairs DHA) will grant you a visa.

If you accept an offer for any UNSW College Pty Limited (UNSW College) registered course including English courses or UNSW Foundation Studies, you must choose one of the care arrangement options acceptable to DIBP.

These options are:

#### Option 1: UNSW College does not provide a Confirmation of Appropriate Accommodation and Welfare (CAAW) Letter

If you choose this option, you will need to reside in Australia with a parent, legal guardian, or a close relative of good character (nominated by both parents) who is 21 or over. This arrangement must be approved directly by DHA.

### **Option 2: UNSW College provides a CAAW Letter**

If you choose this option, UNSW College will need to approve your accommodation and welfare arrangements. You need to present this CAAW Letter from UNSW College to DHA when applying for your Student Visa.

#### You must submit this form together with proof of payment for your accommodation at least 4 weeks before your course begins.

UNSW College follows procedures to ensure that the responsibilities it undertakes in signing CAAW Letters to students are fulfilled. If you require UNSW College to provide you with a CAAW Letter, you must agree:

- to stay in accommodation approved by UNSW College until you turn 18 years of age. If you choose to reside a. in a Homestay, a UNSW College staff member will visit the home and meet with the prospective host family to ensure that the accommodation and welfare arrangements are adequate. If you intend to stay at Scape Darling House/Scape Darling Square/Iglu Redfern/New College/Jacaranda Hall, an International Student Adviser will maintain regular contact with Scape Darling House/Scape Darling Square/Iglu Redfern/New College/ Jacaranda Hall staff to ensure that your accommodation and welfare arrangements are adequate and continue to remain appropriate for your needs.
- b. while UNSW College will try to approve your first choice of accommodation, we may offer alternate accommodation in order to be able to approve your Under 18 Care Arrangement.
- to attend regular scheduled meetings with a Student Adviser (which will be monitored by C. UNSW College). These meetings provide you with the opportunity to discuss any issues you may have about your accommodation and/or host family, academic progress, and any other personal concerns.

#### 2. UNSW College signs the CAAW

In signing the CAAW required for Student Visa processing, UNSW College is undertaking an important responsibility by confirming to DHA that appropriate arrangements have been made for the student's accommodation, support, and general welfare. The CAAW fee for these arrangements is AUD\$150 in 2017, plus an additional AUD\$49 per week in 2017 for every week the student remains under 18 years of age during UNSW College English courses and/or the UNSW Foundation Studies program.

When you have applied to the Homestay agency, you will be invoiced in advance for the placement/administration fee and for four (4) weeks accommodation.

#### You must pay your Homestay fees before submitting this form.

Please note: Homestay fees are additional to the care arrangement fees charged by UNSW College and are invoiced separately by the Homestay agency.

UNSW College will liaise with the agency to confirm that you have applied and paid the Homestay fees. Once Homestay payment has been received, the agency will send a host family profile to UNSW College for approval.

Once the Homestay arrangements are approved by UNSW College, a notice is sent to the Homestay agency which then conducts the appropriate police checks and confirms the Homestay placement with you.

To ensure that the host family will be available to greet you on your first day, the Homestay agency will also require your flight arrival details. It is compulsory for all CAAW students to go directly to their approved accommodation immediately upon arrival.

#### 5. Stay with a Family Friend or Relative with UNSW College Approval

To assess whether the arrangement is appropriate, a UNSW College staff member will visit the proposed accommodation and meet with the nominated friend or relative providing Homestay accommodation for you. Once accommodation is approved by UNSW College, your contact details and the details of your nominated friend or relative are sent to a Homestay agency for registration.

The Homestav agency will send an invoice for the registration/placement fee to you. Once paid, the agency will contact the nominated Homestay and organise a date to register the host family; this procedure includes obtaining working with children checks for all adults living on the premises.
