If you are absent for more than 5 consecutive working days, you must complete this form within 3 working days of your missed class(es) and email it together with a medical certificate or supporting documents to explain why you were absent to: enquiries@unswcollege.edu.au.

Please read the following important information:

- This form is to be used when a student requests leave of absence after they have commenced the course and the enrolment is to be temporarily paused.
- If you submit a LOA form without an official medical certificate, or other official documentation recognized as Compassionate or Compelling evidence, then your form will not be accepted. All supporting documentation must be in English or translated into English by a certified translator.
- If you are unsure about Compassionate or Compelling evidence, please check the list on the last page of the form.
- Please also inform your teachers that you will be absent and request for the class recording so you do not fall behind your studies.
- 5. Please also confirm if you will miss any assessments or exams while you are away.

## Compassionate or Compelling Evidence Can Be Accepted by **UNSW College**

Compassionate and compelling circumstances are matters which are, in most cases, beyond the control of the student and which will impact their capacity to progress with their planned course of study.

In the below table UNSW College sets out what it considers to be compassionate and compelling circumstances, and the documentary evidence required to support a claim.

Compassionate or Compelling Circumstances	Documentary Evidence Required			
Compassionate or compelling circumstances that apply under all UNSW College policies				
Serious illness or injury of a student	Medical certificate from an AHPRA registered practitioner, stating that the student was unable to fulfil attendance / course progressrequirements. Where the student is offshore, other medical evidence may be accepted at UNSW College's sole discretion.			
Death or serious illness of a close family member such as a parent or grandparent.	A death certificate which is written in English or is translated into English by a NAATI accredited translator, or appropriate alternative evidence.			
Major political upheaval or natural disaster in the home country of the student requiring emergency travel by the student that is, or is likely to have, an impact on the student's ability to continue or commence their studies.	Any reasonable evidence of the event, including copies of flight/travel bookings and/or any reasonable evidence of the impact such event has had on the student's studies			
A traumatic experience where a student is victim of, or a witness to, a serious accident or crime, and this experience has adversely impacted on the student.	A hospital report, police report or an AHPRA registered health practitioner's report. Where the student is offshore, other medical evidence may be accepted in UNSW College's sole discretion.			
Misadventure, for example: an unusual/one-off event such as a major traffic incident that prevented the student from being able to travel to and attend class.	Any reasonable evidence of the event.

Any others circumstances that UNSW College considers to be compassionate and compelling in nature, in its sole discretion	Any reasonable evidence of the event.
